Humanitarian Parole Process (https://www.uscis.gov/CHNV)

- Cubans, Haitians, Nicaraguans and Venezuelans outside the U.S. (or immediate family members—spouse/common-law partner and unmarried children under 21)
- Grants advance travel authorization for up to 30k noncitizens each month
- Supporter (USC, LPR, lawful nonimmigrant, Asylee/Refugee, TPS)
- Supporter submits Form I-134A
- USCIS will contact beneficiary via email with subsequent steps (submissions filed with CBP One Mobile App)

Family Reunification Parole Process (https://www.uscis.gov/FRP)

- Advance travel authorization for Colombia, El Salvador, Guatemala, Honduras
- National Visa Center (NVC) will send email invitations to individuals
- Must have approved I-130 petition
- Petitioner will then submit I-134A
- Beneficiary will then submit information using CBP One Mobile App

Temporary Protected Status Updated Designations (https://www.uscis.gov/newsroom/news-releases/temporary-protected-status-designations-for-el-salvador-honduras-nepal-and-nicaragua-reinstated-and)

- El Salvador, Honduras, Nepal, and Nicaragua
- Reinstated and Extended for 18 months
- Only applies to renewals, not new applicants who arrived after the designated continuous residence dates
- El Salvador 13 Feb 2001
- Honduras 30 Dec 1998
- Nepal 24 June 2015
- Nicaragua 30 Dec 1998

Online Filings for Certain Forms (https://www.uscis.gov/file-online/forms-available-to-file-online)

- I-589 (Asylum) https://www.uscis.gov/i-589
- I-765 (Employment Authorization Document) https://www.uscis.gov/i-765
- Requires a USCIS account (https://my.uscis.gov)

Updated Procedures for Applications for Citizenship

- Can file application online (https://www.uscis.gov/n-400)
- Oath Ceremonies can take place the same day of the interview
- Requires a USCIS account

Wait Times/Processing Times

- Still seeing lengthy processing times for most applications/petitions
- Follow processing times online (https://egov.uscis.gov/processing-times/)
- Can make online inquiries once case is outside processing times (https://egov.uscis.gov/e-request/Intro.do)
- Certain receipt notices now extending validity period (e.g., EAD and LPR)

Chicago Immigration Court

- Many filings for new cases can be do online with an account
- New/renewed procedures for processing cases with USDHS outside of hearings (prehearing conferences, prosecutorial discretion, stipulations)
